- 1. I have been practicing in the comprehensive fields of Environmental Health, Occupational Hygiene, and Occupational Health and Safety since 1978.
- 2. Acoustics is the branch of physics concerned with the properties of sound. Occupational Hygiene is the applied science concerned with the prevention of disease and maintenance of health, arising from potential exposures to physical, chemical, or biological stressors, in the workplace. Hearing loss may be caused by exposure to noise (physical stressor), ototoxic substances such as solvents or pharmaceutical agents (chemical stressor), or microbiological agents such as viruses (biological stressor).
- 3. Environmental Health is the branch of public health concerned with the prevention of disease and the maintenance of health arising from potential exposures to environmental stressors, including noise. Health is defined by the World Health Organisation (1947) not only as the absence of disease and infirmity, but also the complete physical, mental and social wellbeing of the individual.
- 4. I have been trained in acoustics; sources and transmission of sound in the work-place; logarithms and statistics; sound measurement instrumentation and techniques; representative and non-representative measurement strategies; biology of hearing; pathophysiology of hearing loss; and health and safety law for the protection of workers from noise.
- 5. I have visited thousands of different work-places since 1978.
- I have carried out several hundred noise surveys since 1978 to identify significant sources of noise exposures predict the risk of hearing loss from noise exposures and to check compliance with legislation or standards.
- I have advised employers on complying with the Department of Employment (DoE, 1972) Code of practice on protecting employed persons from noise, the Noise at Work Regulations 1989 and the Control of Noise at Work Regulations 2005.
